POLYURETHANE ADHESIVE IN WATER DISPERSION, WITH VERY HIGH THERMAL RESISTANCE

• USE

High thermal resistance adhesive suitable to bond PU, PVC and leather. **ECOSAR 135 C** is a good alternative to solvent polyurethane adhesives. It combines the advantages of water-basis adhesive with high quality bonding properties. After application **ECOSAR 135 C** has to be reactivated at $60 - 70^{\circ}$ C. This adhesive is recommended to be used with HYDROVER dyeing products.

- APPLICATION
- Accurately prepare the surfaces to be bonded
- evenly apply ECOSAR 135 C by soft brush, well distribute the adhesive avoiding product excessive accumulation.
- when the adhesive is dry (i.e. the product becomes transparent), it is necessary to reactivate it at 60-70°C
- stick and immediately press
- final bonding after 48 hours

<u>Notes</u>: it is suggested to use the adhesive at temperatures not lower than 18°; in case the material is stocked in cold room, recondition before using

MATERIALS

* PU SOLES

Evenly rough the sole and apply ECOSAR 135 C + 1,5/2% CAT 200. Roughing process is essential because it removes every impurity from the sole due to aging or presence of release agent.

POLYURETHANE ADHESIVE IN WATER DISPERSION, WITH VERY HIGH THERMAL RESISTANCE

* PVC SOLES

Wash the sole by a cotton cloth soaked with **SOLVENTE 31714** or **SOLVENTE LB-20** (without POLVERE LB-20), let dry for 5 minutes and then apply **ECOSAR 135** C + 1,5/2% **CAT 200**.

* TR SOLES

CAUTION! BONDING PROCESS DEPENDING VERY MUCH ON THE QUALITY OF RUBBER TR USED FOR SOLES MOULDING. Apply **BAGNO LB-20** (SOLVENTE LB-20 + POLVERE LB-20) and wait at least for 20 minutes. It is important that the brush has no metal components which could react with BAGNO LB-20. Then apply **ECOSAR 135** C + 1,5/2% **CAT 200**.

* TUNIT SOLES (NEOLITE)

Evenly rough. Apply **BAGNO LB-20** (as per TR soles), wait for 20 minutes and then apply **ECOSAR 135** C + 1,5/2% **CAT 200**.

* SBR RUBBER SOLES


Evenly rough. Apply **BAGNO LB-20** and at least wait for 30 minutes. Then apply **ECOSAR 135 C + 1,5/2% CAT 200**.

* EVA SOLES

Evenly rough. Apply **EVA PRIMER 311704** and wait for 20 minutes. Then apply **ECOSAR 135** C + 1,5/2% CAT 200.

If you have an irradiation machine with mercury lamps, wash with SOLVENTE 31714 and wait for 2/3 minutes. Apply PRIMER EVA UV 311708 and irradiate. Then apply ECOSAR 135 C + 1.5/2% CAT 200.

• STORAGE
